## Experience

I have over 20 years of experience in personal data protection law. I have gained my professional expertise, among others, as an employee of the personal data protection authority and the banking sector. I have know-how in the area of implementation of GDPR in financial institutions and in administrative proceedings, as well as in drawing up internal regulations and documentation on personal data protection.

Additionally, I specialize in banking and finance law cybersecurity and law of new technologies. I am a member of the GDPR Working Group of the Polish Bank Association whose aim is to work out stances for the banking sector and clarify problematic issues related with the personal data protection, reported by financial institution.

I assist companies in the following areas:

- I hold the function of the Data Protection Officer in organisations with various profiles of activity (among others in financial and insurance institutions).
- I provide expert knowledge in the matters of personal data protection.
- I implement GDPR in small, medium and large enterprises.
- I coordinate audits of compliance with the personal data protection law.
- I conduct group training and individual workshops on personal data protection.
- I am a co-author of codes of conduct for personal data protection in various industries.
- I represent clients in administrative and court proceedings.
- I provide legal assistance in the area of civil law and banking law to banks and financial institutions.
- I conduct training sessions, workshops and scientific conferences.
- I draw up procedures, policies and other documents governing the work of debt collection companies.
- I advise in the matters of cybersecurity and the law of new technologies.
